**City Lake B/G Algae condition update** – State Wildlife testing continues. Conditions are currently in a “Watch” status. Watch for updates on the City Facebook Page.

**Election of City Government** – Tuesday, November 7 is Election Day! You’ll be voting for SFT School Board, Extension District positions, and Overbrook City Mayor and two Council seats. In addition to the candidates listed on the ballot, “Write-In” candidates that agree to serve can be elected. If a Council seat is not filled by election, the new Mayor and Council will fill the empty seat by appointment. Candidates for City offices include Jon Brady, candidate for Mayor and Carol Baughman, candidate for Council plus Sheila Dale and Cheryl Miller, both running as write-in candidates for Council seats. A Sample Ballot will be posted, as soon as it’s available. The newly elected will be sworn in to office at a Special Council Meeting on Monday, January 8, 2018.

**Overbrook Betterment Committee** – is currently working on a plan to redo the city mural on 56 Highway on the Elk Township building. Julie Gibbs painted the current mural in 2001. She retains rights to the graphic and therefore it will need to be replaced and not just touched up or repainted. Betterment is wanting your input regarding design specifics for the new mural. 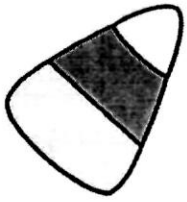

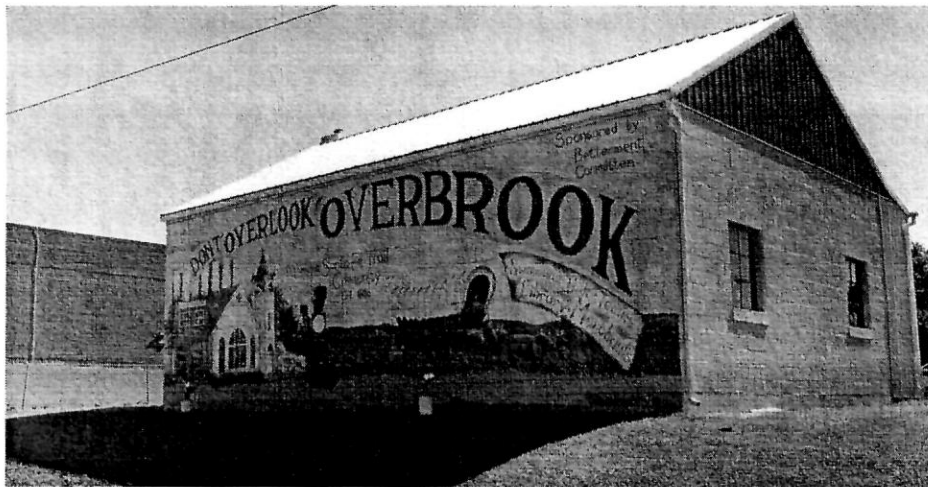

This presents the perfect opportunity for everyone to give their input on how the sign can be repainted to best represent our town. When people from out of town find out you're from Overbrook what do you hear, "Don't Overlook Overbrook! With the paint deterioration that has occurred, it must be completely repainted and we want your ideas on how we can best feature our town through this mural.

# IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

## Monitoring Requirements Not Met for City of Overbrook

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During Third Quarter 2016 we did not monitor for Disinfection Byproducts as required by Kansas Administrative Regulations. Even though this was not an emergency, as our customers you have a right to know what happened and what we did to correct the situation.

What should I do?

You do not need to use an alternative (e.g., bottled) water supply. However, if you have specific health concerns, consult your doctor.

What does this mean?

This is not an immediate risk. If it had been, you would have been notified immediately. However, Some people who drink water containing trihalomethanes and/or haloacetic acids in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous systems, and may have an increased risk of getting cancer.

What happened? What is being done?

We gave public notice 4/28/17 when we mailed our 2016 Consumer Confidence Report with our monthly Utility Bill indicating that in the third quarter of 2016 we failed to correctly submit the samples for Disinfection Byproducts. This sample is to be completed during the hottest quarter so we had to wait until it was time to take the 2017 samples for Disinfection Byproducts. We did so during the third Quarter of 2017 and just recently got the sample results back from the KDHE Lab. Our 2017 DBP figures met the requirements for TTHM and HAA5. We are in compliance with the Disinfection Byproduct requirements.

We anticipate resolving the problem within [estimated time frame]: The original issue was that we received the 2016 sample bottles late on a Friday afternoon and that was resolved this year as we received the sample bottles promptly and subsequently submitted them on time.
