Overbrook, Fansas Spn 24, 1978 The special council meeting was called to order by the Mayor at 7:30 P.M. January 25, 1978 at the City Hall

Roll call answered by Davina Jones, Dr. Bruce Cole, Gordon Hummel, and Lynn Schoonover.

The specific reasons for the meeting was read by the Mayor.

A letter from Mr. Oblinger was read, also a draft of a letter to the Jones Trust. An agreement form between Oblinger &Smith and the City setting fees and responsibilities was discussed. A motion was made by Cole to send letter to Jones Trust applying for planning money and to sign agreement with Oblinger if such money was granted. Seconded by Schoonover, passed unamimously

The Mayor presented an updated fire department plan to the Gouncil as well as an application for matching funds to buy protective clothing. After some discussion a motion made by Schoonover to accept the updated plan and to send the application was seconded by Cole, motion passed unamimously.

Motion made to adjourn by Jones, seconded by Schoonover passed unamimously.

The regular monthly meeting of the Overbrook City Council was held at City Hall on Wednesday evening February 8, 1978 with Mayor Ufford presiding. Roll call was answered by council members Bruce Cole, Davy Jones and Gordon Hummel. Absent were Council members Lynn Schoonover and Nadine Cordts. Also present were Ted Watchous, Chris Cox, Dale Fox, Mrs. and Mrs. Ken Greene, Mrs. Karen Hesseltine and Mrs. Mary Gale. The minutes of the previous meeting were read and approved.

A list of the City's bills was read. Two more bills were added, Darrell Leonard, \$50 and National Sherriffs' Assn. \$203, for Insurance on the City Marshall. It was moved by Bruce Cole and seconded by Gordon Hummel to pay the City's bills. Motion carried unanimously.

Mrs. Hesseltine and Mrs. Gale, representing a committee from the Santa Fe Trail USD No. 434, ask the Council to look at water dept. figures dealing specifically with sewage plants capacity. Their committee is examining projected county growth figures to make the most efficient use of the available buildings and to plan for the future.

Mayor Ufford was called away from the meeting at 7:57 p.m. Bruce Cole took over. Some discussion followed on the available buildings for future schools and the building of new homes in Carbondale and Overbrook. Mrs. Hesseltine and Mrs. Gale left the meeting at 8:15 p.m.

Mayor Ufford returned to the meeting at 8:20 p.m. Mrs. and Mrs. Greene left the meeting at 8:20 p.m.

Council stated an effort was being made to contact Gene Hanner to clean the snow off the city streets. A discussion followed as to making preparations in the Fall with Co-op to use a spreader to help keep city streets clear of snow.

The City Clerk reported on the progress of water bills being paid at City Hall. Two written comments were read. Council discussed the possibility of installing a drop box at City Hall.

Unfinished business: The narrowing of Maple street was discussed. Mrs. Jones suggested the property owners involved be approached. Mayor stated there were many legal aspects to consider. Council agreed to table the project until the Mayor or Council members were able to talk with the City Atty.

Mayor Ufford read a letter of recomendation from New Hartford, Iowa Councilman Mike Puck on Tom Miller.

Bruce Cole asked if the ladder had been purchased for the Fire Dept. and if the Zoning ordinance was ready? Also if we had heard from Workman's Composition on the claim of Steve Brown.

Compensation

Following a discussion on the Powell situation, Council agreed for Davy Jones to contact Helen Miachel to set up a meeting with Atty. General Kirk Schiender for February 16, to discuss failure of the County Atty. to try certian cases.

Gordon Hummel reported on a telephone conversation with the Gas Service Co. It's proposed to have the gas bills at City Hall by April 1.

After discussing the need for new fire exstinguishers to fight grease and oil fires, Davy Jones moved to purchase four fire exstinguishers with billing for two to go to Township. Seconded by Bruce Cole. Motion carried unanimously.

Discussion followed on the Christmas lights and brackets to hold the stars. Clarification as to who will be in charge of this project is needed.

After discussion on the Western Auto apartment, Schwanke Laundary and Wakarusa Watershed water bills, Council agreed to a mim. water bill to Wakarusa Watershed.

Mayor Ufford threw out to the Council information and concern for the conserving of our water.

A letter from Virginia Kersten, Osage County Clerk, requesting use of City Clerk's office for registration points, will be answered by the city clerk.

A letter asking for information on events for the year in the city, was turned over to Chamber of Commerce.

Bruce Smith entered the meeting at 10:00 p.m.

On motion of Davy Jones, the meeting adjourned at 10:15 p.m.

The regular meeting of the Overbrook City Council was called to order March 8, 1978 with Mayor Ufford presiding. Roll call was answered by council members Bruce Cole, Gordon Hummel, Nadine Cordts and Davy Jones. Lynn Schoonover was absent for roll call. Also present were Ted Watchous, Dale Fox, Mr. and Mrs. Ken Greene, Mr. and Mrs. Orville Rule and Dave Rule, Mr. and Mrs. Bob Sisson and John Kramer. Minutes of the previous meeting were approved as read.

It was moved by Gordon Hummel and seconded by Nadine Cordts that the bills for the city be allowed. Motion carried.

Beth Sisson, representing the J.C. Jaynes, was introduced. She advised the J.C. Jaynes wished to see that street signs are purchased and installed on the streets. She advised several clubs and organizations are to donate moneys as well as the J.C. Jaynes and requested a commetment from the city council to stand at least 50% of the amount if needed, however, she felt it would be less than 50% for the city. Mayor Ufford advised that the cost of the signs would be near \$1300.

The City Council agreed to support the project up to 50% if needed. And it was felt free labor would be needed for installing the signs. Mr. and Mrs. Sisson left the meeting at 7:50 p.m. Ted Watchous left the meeting at 7:55 p.m.

Mr. and Mrs. Orville Rule requested the city pay for the damage to their son Jim's house caused by a sewer stoppage. The bill was in the amount of \$872. Dale Fox explained to the council members that after trying to take care of the problem, the Ace Sewage Co. of Kansas City was contacted to complete the cleaning of the sewer pipes. A motion by Bruce Cole was made to disallow the claim as 1t would set a precendent. As there was no second to the motion, Bruce Cole withdrew his motion.

Mayor Ufford then advised in a telephone conversation with Steve Jones, City Attorney, that the city was not liable for the problem of sewer stoppage. Bruce Cole again submitted his motion to disallow the bill. Nadine Cordts seconded the motion advising the motion was being seconded on the basis of the telephone conversation with Steve Jones. Motion carried unaminously. Mayor Ufford advised the Rules they, if they so desired, could sue the city if they saw fit to do so.

Lynn Schoonover entered the meeting at 8:10 p.m. Mr. and Mrs. Greene left the meeting at 8:10 p.m. Mr. and Mrs. Rule and Dave Rule left the meeting at 8:20 p.m.

John Kramer was given the floor to explain the findings of the firm of Kramer Engineering concerning water projection for the city of Overbrook. All members were provided an Engineering report pamphlet and Mr. Kramer explained many details of the report. Discussion and questions followed. It was agreed the council members would study the report and Mr. Kramer would return on April 12, 1978 to answer any further questions the members might have on their findings. Mr. Kramer left the meeting at 8:55 p.m.

Ted Watchous entered the meeting at 8:55 p.m.

Mayor Ufford submitted several old water bills to the Council for their decision as to write them off as bad bills or try to collect. After discussion a motion was made by Bruce Cole to try to collect the unpaid bills. Gordon Hummel seconded the motion. Motion Carried.

Davy Jones, member of the planning Committee, advised the public meeting of March 7 resulted in no objections as no one other than four members of the Planning Commission attended.

Hommel made motion To people Ord 95- Joning ordinance Dray Sen Hommel made a motion to charge a \$10 building fee on ord. #95. Nadine Cordts seconded. Ord. #95 will be published in the official paper.

An open discussion followed regarding the Fair Board meeting of March 6, 1978, as to what was accomplished at the meeting. Mayor Ufford selected a committee of three: Nadine Cordts, Lynn Schoonover and Gordon Hummel to serve from the city council for the planning of the park if the Fair Assn. cared to come to an agreement with the City of Overbrook by March 31, 1978. There are to be three council members, three from the Fair Board and one at large.

Mayor Ufford presented K.P. & L.'s contract which would pay the city for collecting the light bills. Council approved.

The Mayor advised the city will receive \$505 for Fire Dept. use. The amount was \$1010, the other 50% to be matched by the City of Overbrook. These moneys in the amount of \$505 were allowed through the Extension Title 4 Grant. Mayor Ufford read a letter from Tom Miller regarding the Fire Dept. operation. A Fire Meeting is to be held on March 17, at 7:00 p.m.

Also reported was a trip to the Attorney General's office by Mayor Ufford and Gordon Hummel to consult with Bruce Wassinger as to failure of the County Attorney to cooperate on warrants etc. It was felt the trip was successful, as results were gratifying.

A motion was made by Bruce Cole for the purchase of appropriate flags to be placed in the council room. Motion seconded by Lynn Schoonover. Motion carried.

Nadine Cordts reported she had a qualified pool employee for the city pool but wished the council members approvial as the application was from her daughter, Kris Hughes. The council approved hiring Kris Hughes. This completes pool employees for the summer: Joyce Westburg, Kris Hughes and Coleen Reece.

Motion was made by Davy Jones and seconded by Nadine Cordts to adjourn to an executive session for the purpose of discussing personnel problems. Motion carried. Council went into executive session at 10:55 p.m. to reconvene at 11:55 p.m.

Council reconvened at 11:50 p.m. Bruce Cole moved Tom Miller be hired on a 90 day probationary period for 16 hours a week at mim. wage. Any other time would be volunteer time. Ted Watchous would be responsible for Mr. Miller during the probation period. Ted Watchous agreed. Lynn Schoonover Seconded. Motion carried unanimously.

Lynn Schoonover moved that the question of a pay raise for Dale Fox remain as is for a period of 90 days and reviewed at that time. Nadine Cordts seconded. Motion carried..

Davy Jones made a motion to adjourn. Motion seconded and meeting adjourned at 12:05 a.m.

The regular meeting of the Overbrook City Council was called to order April 12, 1978 at 7:30 p.m. by Mayor Ufford.

Roll call was answered by Council members: Bruce Cole, Gordon Hummel, Nadine Cordts and Davy Jones. Lynn Schoonover was absent from the meeting. Also present: Mr. and Mrs. Ken Greene, Bruce Smith, Skip Mann, Mrs. Lucille Gustin, Shirley Karr, Harold Odgers, Wm. Comptom, two representative from Karrousel Kemical Corp. and Max Friesen. The minutes of the previous meeting were read and corrected, then approved as read.

It was moved by Davy Jones and seconded by Nadine Cordts that the bills for the city be allowed. Motion carried.

Mr. Harold Odgers came before Council asking to see the City's new zoning ordinance, he was advised a copy would be published in the Citizen news paper Thurs., April 13, 1978. Mr. Odgers and Mrs. Karr, who both have homes located in the commerical area, wanted to know who had jurisdiction on what was built on the city's com merical property. Council informed Mr. Odgers and Mrs. Karr of the board of appeals, a group appointed by the City Council to look into any permit that is protested. Mr. Odger was also anxious about the up-dating of utilities when they became inadequate with growth in the area.

Mrs. Lucille Gustin was present to complain of a tree limb falling from a tree located on city property in front of her house. The limb fell on an auto causing some damage. Mrs. Gustin was advised the city could not take responsibility for this, that she could bring and estimated amount of the repairs to city hall and it would be sent to the City Attorney.

Bill Harrison, Maryin Deshazer entered the meeting at 7:50 p.m. Leonard Atchison entered at 8:00 p.m.

Mr. Comptom was present to complain of sewer stoppage on his property. He wants some action taken. Monday, April 10, Dale Fox checked the lift station, it was running on half capacity since lighting struck the switchboard during a resent rain storm. Council ask Dale to look again at the sewer on Mr. Comptom's property and report to Mr. Comptom. Mr. Comptom left the meeting at 8:07 p.m.

Mr. Bill Harrison presented Council with information about the rural water district hooking onto Shawnee 8 water district. He wish to know if Overbrook would be interested in sharing the cost and having a back-up water supply. He invited Council to a meeting at Toppings at 3:30 p.m. April 13. Mr. Harrison left the meeting at 8:15 p.

Mr. Marvin Deshazer ask permission from Council for a loading zone north of his place of business. After a short discussion it was moved by Gordon Hummel and seconded by Bruce Cole to allow 12 feet for a loading zone on the north side of Market Street, on the south side of the Miller Building. Motion carried. Mr. Deshazer left the meeting after motion was made.

Mr. Skip Mann, representing the Athletic Assn., ask Council to help pay for the lights at the baseball field. After some discussion it was moved by Gordon Hummel and seconded by Nadine Cordts that the city will pay for the lights excluding any maintenance of facilities. Motion carried. Mr. Mann 10ft the meeting at 8:30 p.m.

Greene's Sanitation requested permission to leave a dumpster at the north end of the driveway at the swimming pool. Council agreed. Mr. and Mrs. Greene left at 8:35 p.m. Also Mr. Odger and Mrs. Karr left at 8:35 p.m.

Mr. Leonard Atchison, wishing to build a house on 3 lots west of the Baptist Church, wanted the Council to be aware of his problem of hooking onto a sewer. Either the city sewer or the Church sewer. Council advised him to read up on ordinances for more information on what he could do. Mr. Atchison left the meeting at 8:50 o.m. Mrs. Gustin left at 8:50 p.m.

Mr. Jack Kramer of Kramer Engineering was present for questions or any discussion on his report of the city's water supply. Council agreed another well was needed. Questions about the adequacy of the pumps was raised. A special meeting may be needed to discuss an improvement program and cost estimates. Mr. Kramer left the meeting at 9:15 p.m.

Two representatives of the Karrousel Kemical Corp. presented a booklet for Council to view. They were requesting to work with Dale Fox in treating our lagoons with their chemical product. Council will not make a decision about their product until they can check with their present customers, etc. And will bring this to a special meeting on the water system. The representatives left the meeting at 10:15 p.m.

Tom Miller and Ted Watchous entered the meeting at 10:00 p.m.

After a lengthy discussion of the city's street signs it was moved by Nadine Cordts and seconded by Gordon Hummel to place a reduce speed sign beyond the city limits, both north and south, on county roads. Motion carried, with the permission of the County Commission.

Mayor Ufford informed the Council of the \$1.00 charge on the country water bills was an easement agreement.

Mayor Ufford plans to talk to Darrell Leonard about his checks on the lift stations.

The city plans to try out a new backhole.

Instruction were given to Dale Fox to read some meters each week to prevent an overload of work making out the bills at the end of the month.

City needs bill from Fire Equip. Co. to go ahead with application of grant for money.

The city will work with the County Civil defense and acquire three small sierns for the city to have adequate tornado alarm.

A motion was made by Nadine Cordts to replace the under water lights at the swimming pool. Seconded by Davy Jones. Motion carried.

Council disagreed.

Council agreed to get more pamphlets on alcohol and drug abuse.

Max Friesen gave a financial statement.

A motion was made ot adjourn by Davy Jones and seconded by Bruce Cole. The Meeting adjourned at 11:45 p.m.

Special meeting called to order by Mayor Calvin R. Ufford at 7:30 P.M? April 27, 1978 at the City Hall, as requested. (Form attached.)

Roll Call answered by Davy Jones, Nadine Cordts, and Dr. Bruce Cole.

The appraisal was read and after a short discussion the unamimous decision of the Council was that the appraised value of the 14 acres for \$42,000.00 was too high.

After considerable discussion it was decided to authorize the Mayor to make a counter-offer of \$25,000.00 for the original 10 acres.

Motion to adjourn carried unanimously at 9:30 P.M.

Special meeting called to order by Mayor Calvin Ufford at 8:00 P.M. May 1, 1978 at the City Hall as requested (form attached)

Roll call answered by Dr. Burce Cole, Davy Jones, Lynn Schoonover, Nadine Cordts, Also present were Max Freisen, Frank Sabatini, and Don Tutcher.

Mr. Ufford started the discussion by re-capping the previous meeting on April 27 and also his counter-offer of \$25,000.00 to Max Freisen, then asked for general discussion. Mr. Sabatini offered to sell the City the original 10 acres for \$30,000.00 and donate an additional 9 acres.

The Council discussed this proposal at some length and Nadine Cordts recounted her telephone conservation with Mr Oblinger's office this morning. The decision of the Council is that the price is too high, but in order to keep the recreation program going the Council has only two choices, either drop the program for this year or make application to the Jones Trust for \$30,000.00 and the Devemopment Corporation would donate to the City 9 acres(low ground not suitable for housing). It was generally agreed this would defeat the purpose by keeping the price per acre too high.

Mr. Ufford asked Mr. Sabatini if it would be agreeable to the Corporation to make application to read \$30,000.00 for 19 acres more or less, Mr. Sabatini agreed.

Lynn Schoonov r made the motion to make the application to the Jones Trust to purchase 19 acres more or less for \$30,000.00. Motion seconded by Dr. Bruce Cole, vote was 3 affirmative, one abstaining.

Max Freisen, Frank Sabatini, and Don Tutcher left the meeting at approx. 9:30 P.M.

Mayor Ufford submitted the names of Larry Coffman, Lynn Schoonover, John Jewell, Dorthy Flory, and Marvin Deshazer for The Board of Appeals as required by Ord. 95. Unanimously approved

Mr. Miller reported on the Fire Department. A list of needed equipment was shown to Council members. They were informed that there are different funds available for this equipment. Mr. Schoonover asked about going to Surplus Property in Topeka to find equipment. A suggestion by Mrs. Cordts to appoint a committee to look into these needs was discussed. Council agreed to a committee of Mr. Ufford, Mr. Hummel and Mr. Miller to meet and discuss the need for equipment for the Fire Department. Mr. Miller left the meeting at 8:10 p.m.

Greene Sanitation - Mr. Greene agreed to place a dumpster at the Locker Plant for the \$10.00 per month charge.

Mrs. Ruth Morgan, having become disabled, is unable to bring her trash out to the street. A discussion resulted in a motion being made by Mr. Hummel to give Greene Sanitation permission to go onto Mrs. Morgan's property to pick up her trash, due to her disability. Seconded by Mrs. Jones. Motion carried una. Mr. and Mrs. Greene left the meeting at 8:25 p.m.

The Mayor explained the correction on 'BrookTimes water bill.

Mr. Frank Boyd, reporting for the Planning Commission, read through a proposed zoning ordinance along with the Council members. Some changes were made. The proposed ordinance will be sent to Mr. Steve Jones, City Attorney, for examination. A new zoning map of the city was shown to the Council. Some discussion followed. Mr. Boyd left the meeting at 9:45 p.m.

The City Clerk read a list of overdue water bills. After a brief discussion it was moved by Mrs. Cordts and seconded by Mrs. Jones to instruct Dale Fox to contact persons about overdue water bills, they will have a ten (10) day grace period, then water will be turned off until the bills are paid in full. Motion carried una.

Mrs. Cordts reported she had contacted Joyce Westberg and Colleen Reese about working at the swimming pool this summer. They are interested in employment. CETA money for pool people will be available.

Utilities - 4,000 new water bills were delivered. Dr. Cole will again talk with Mr. Harth of K.P.&L. and Mr. Hummel will check again with the Gas Service Co.; to speed up transition of collection of utility bills at City Hall.

False Arrest Insurance - Council agreed Mr. Watchous, Chief of Police, must have "high risk" insurance. Mr. Fox will also be covered.

The Council agreed to buy a ladder for the fire truck.

Mayor Ufford proposed how the water bills will be read each month by Mr. Fox.

Two checks were presented, \$90 to the Post Office for a three month supply of stamps; \$50 for petty cash. To take care of collection of utility bills at City.

Everything is "go ahead" on sewer change at the Nursing Home. Mr. Don Hylton will be contacted about easements.

A bill from Dr. Dellyn H. Malley, Chiropractor, for Steve Brown's back treatments was presented to Council. Mayor Ufford ask the Council to refuse payment. Council agreed to turn the bill over to Workman Compensation.

A letter from the City's Insurance Co. concerning Robert Brown's threat of suit against the City, was read to the Council.

A report of the Treasurer showed a January balance of \$11,005.86 for water fund and -\$292.24 for general fund.

Mrs. Cordts reported a letter was being sent to the City by Mr. Oblinger.

Mr. Hummel asked when sewer rent would begin in Western Heights The sewer bond showed this would begin on September 1 of 1980. A discussion on narrowing up Market Street was tabled until next meeting.

Council asked for a letter to be sent to Krammer Engineering in Topeka on our water study.

A discussion about the Powell case and its disposition by the County Attorney resulted in Council giving permission to write to the Melvern City Council to make plans to go to the Attorney General for help.

Mrs. Jones moved to adjourn at 12:05 a.m.; seconded by Mr. Schoonover.

The regular meeting of the Overbrook City Council was called to order April 12, 1978 at 7:30 p.m. by Mayor Ufford.

Roll call was answered by Council members: Bruce Cole, Gordon Hummel, Nadine Cordts and Davy Jones. Lynn Schoonover was absent from the meeting. Also present: Mr. and Mrs. Ken Greene, Bruce Smith, Skip Mann, Mrs. Lucille Gustin, Shirley Karr, Harold Odgers, Wm. Comptom, two representative from Karrousel Kemical Corp. and Max Friesen. The minutes of the previous meeting were read and corrected, then approved as read.

It was moved by Davy Jones and seconded by Nadine Cordts that the bills for the city be allowed. Motion carried.

Mr. Harold Odgers came before Council asking to see the City's new zoning ordinance, he was advised a copy would be published in the Citizen news paper Thurs., April 13, 1978. Mr. Odgers and Mrs. Karr, who both have homes located in the commerical area, wanted to know who had jurisdiction on what was built on the city's com merical property. Council informed Mr. Odgers and Mrs. Karr of the board of appeals, a group appointed by the City Council to look into any permit that is protested. Mr. Odger was also anxious about the up-dating of utilities when they became inadequate with growth in the area.

Mrs. Lucille Gustin was present to complain of a tree limb falling from a tree located on city property in front of her house. The limb fell on an auto causing some damage. Mrs. Gustin was advised the city could not take responsibility for this, that she could bring and estimated amount of the repairs to city hall and it would be sent to the City Attorney.

Bill Harrison, Marvin Deshazer entered the meeting at 7:50 p.m. Leonard Atchison entered at 8:00 p.m.

Mr. Comptom was present to complain of sewer stoppage on his property. He wants some action taken. Monday, April 10, Dale Fox checked the lift station, it was running on half capacity since lighting struck the switchboard during a resent rain storm. Council ask Dale to look again at the sewer on Mr. Comptom's property and report to Mr. Comptom. Mr. Comptom left the meeting at 8:07 p.m.

Mr. Bill Harrison presented Council with information about the rural water district hooking onto Shawnee 8 water district. He wish to know if Overbrook would be interested in sharing the cost and having a back-up water supply. He invited Council to a meeting at Toppings at 3:30 p.m. April 13. Mr. Harrison left the meeting at 8:15 p.

Mr. Marvin Deshazer ask permission from Council for a loading zone north of his place of business. After a short discussion it was moved by Gordon Hummel and seconded by Bruce Cole to allow 12 feet for a loading zone on the north side of Market Street, on the south side of the Miller Building. Motion carried. Mr. Deshazer left the meeting after motion was made.

Mr. Skip Mann, representing the Athletic Assn., ask Council to help pay for the lights at the baseball field. After some discussion it was moved by Gordon Hummel and seconded by Nadine Cordts that the city will pay for the lights excluding any maintenance of facilities. Motion carried. Mr. Mann 10ft the meeting at 8:30 p.m.

Greene's Sanitation requested permission to leave a dumpster at the north end of the driveway at the swimming pool. Council agreed. Mr. and Mrs. Greene left at 8:35 p.m. Also Mr. Odger and Mrs. Karr left at 8:35 p.m.

Mr. Leonard Atchison, wishing to build a house on 3 lots west of the Baptist Church, wanted the Council to be aware of his problem of hooking onto a sewer. Either the city sewer or the Church sewer. Council advised him to read up on ordinances for more information on what he could do. Mr. Atchison left the meeting at 8:50 o.m. Mrs. Gustin left at 8:50 p.m.

Mr. Jack Kramer: of Kramer Engineering was present for questions or any discussion on his report of the city's water supply. Council agreed another well was needed. Questions about the adequacy of the pumps was raised. A special meeting may be needed to discuss an improvement program and cost estimates. Mr. Kramer left the meeting at 9:15 p.m.

Two representatives of the Karrousel Kemical Corp. presented a booklet for Council to view. They were requesting to work with Dale Fox in treating our lagoons with their chemical product. Council will not make a decision about their product until they can check with their present customers, etc. And will bring this to a special meeting on the water system. The representatives left the meeting at 10:15 p.m.

Tom Miller and Ted Watchous entered the meeting at 10:00 p.m.

After a lengthy discussion of the city's street signs it was moved by Nadine Cordts and seconded by Gordon Hummel to place a reduce speed sign beyond the city limits, both north and south, on county roads. Motion carried, with the permission of the County Commission.

Mayor Ufford informed the Council of the \$1.00 charge on the country water bills was an easement agreement.

Mayor Ufford plans to talk to Darrell Leonard about his checks on the lift stations.

The city plans to try out a new backhole.

Instruction were given to Dale Fox to read some meters each week to prevent an overload of work making out the bills at the end of the month.

City needs bill from Fire Equip. Co. to go ahead with application of grant for money.

The city will work with the County Civil defense and acquire three small sierns for the city to have adequate tornado alarm.

A motion was made by Nadine Cordts to replace the under water lights at the swimming pool. Seconded by Davy Jones. Motion carried.

Council disagreed.

Council agreed to get more pamphlets on alcohol and drug abuse.

Max Friesen gave a financial statement.

A motion was made ot adjourn by Davy Jones and seconded by Bruce Cole. The Meeting adjourned at 11:45 p.m.

Special meeting called to order by Mayor Calvin R. Ufford at 7:30 P.M? April 27, 1978 at the City Hall, as requested. (Form attached.)

Roll Call answered by Davy Jones, Nadine Cordts, and Dr. Bruce Cole.

The appraisal was read and after a short discussion the unamimous decision of the Council was that the appraised value of the 14 acres for \$42,000.00 was too high.

After considerable discussion it was decided to authorize the Mayor to make a counter-offer of \$25,000.00 for the original 10 acres.

Motion to adjourn carried unanimously at 9:30 P.M.

Special meeting called to order by Mayor Calvin Ufford at 8:00 P.M. May 1, 1978 at the City Hall as requested (form attached)

Holl call answered by Dr. Burce Cole, Davy Jones, Lynn Schoonover, Nadine Cordts, Also present were Max Freisen, Frank Sabatini, and Don Tutcher.

Mr. Ufford started the discussion by re-capping the previous meeting on April 27 and also his counter-offer of \$25,000.00 to Max Freisen, then asked for general discussion. Mr. Sabatini offered to sell the City the original 10 acres for \$30,000.00 and donate an additional 9 acres.

The Council discussed this proposal at some length and Nadine Cordts recounted her telephone conservation with Mr Oblinger's office this morning. The decision of the Council is that the price is too high, but in order to keep the recreation program going the Council has only two choices, either drop the program for this year or make application to the Jones Trust for \$30,000.00 and the Devement Corporation would donate to the City 9 acres(low ground not suitable for housing). It was generally agreed this would defeat the purpose by keeping the price per acre too high.

Mr. Ufford asked Mr. Sabatini if it would be agreeable to the Corporation to make application to read \$30,000.00 for 19 acres more or less, Mr. Sabatini agreed.

Lynn Schoonov r made the motion to make the application to the Jones Trust to purchase 19 acres more or less for \$30,000.00. Motion seconded by Dr. Bruce Cole, vote was 3 affirmative, one abstaining.

Max Freisen, Frank Sabatini, and Don Tutcher left the meeting at approx. 9:30 P.M.

Mayor Ufford submitted the names of Larry Coffman, Lynn Schoonover, John Jewell, Dorthy Flory, and Marvin Deshazer for The Board of Appacas as required by Ord. 95. Unanimously approved

The regular monthly meeting of the Overbrook City Council was held at City Hall, Wednesday evening, May 10, with Mayor Calvin Ufford presiding. The Meeting came to order at 7:30 p.m. Roll call was answered by Bruce Cole, Davy Jones, Nadine Cordts and Lynn Schoonover. Gordon Hummel was absent. The minutes of the previous regular meeting were approved as read. Minutes of special meetings April 27 and May 1 were approved as read.

Also present were Chris Cox, Mr. and Mrs. Bob Sisson, Bruce Smith, Dale Fox, Mr. Phil Blue and Mr. and Mrs. Ken Greene.

A list of bills was presented, added was \$50 to Darrell Leonard. It was moved by Bruce Cole and seconded by Nadine Cordts, to pay the bills.

Beth Sisson, representing the Overbrook Jaycee Jaynes, reported on the street sign fund raising project. She showed council a poster with pictures of nearby towns the size of or smaller than Overbrook. And reported nearly \$300 had been raised. The council agreed to match the funds raised for the signs. Mayor Ufford advised Mrs. Sisson to go ahead and order the signs needed. Council agreed. Beth and Bob Sisson left the meeting at 7:47 p.m.

Mr. Phil Blue, a representative of the Law Enforcement Agency Equipment Co., Kansas City, MO proposed a plan to add two sirens to the city's warning system and relocating the present siren. This plan could cost the city as much as \$5,000 and chances of getting a grant were small. No action was taken by the council. Mr. Blue left at 8:23 p.m.

Mr. and Mrs. Greene left the meeting at 8:30 p.m.

After a brief discussion it was moved by Lynn Schoonover and seconded by Nadine Cordts to offer Greene Sanitation a 15 cents per resident, per month increase.

Making a total of \$2.15 per resident per month for Greenes becoming effective July 1, 1978. Motion carried.

Nadine Cordts, reporting for the swimming pool, stated that the pool had its new underwater lights. Supplies for the concession stand had been ordered. There will be a meeting with the girls May 18. Dale Fox will drain and clean the pool and it will open May 28.

Council, taking a 10 minute recess, looked at a tractor with back-hoe the city may purchase. Reconveneing, they discussed the back-hoe which will cost \$10,000. It was decided the city would keep it for a few weeks and try it out on some sewer work in progress.

There was discussion of a sewer hook-on being found in the middle of Don Keim's backyard. Dale Fox will talk to Mr. Kiem.

The tree limb that fell in front of Lucille Gustin; s house was discussed. Council will have somone check the property to be sure the tree is not on city property.

Council disagrees with the percent of water Leo's Cafe declares it need pay tax on.

Ordinance #8, a fire ordinance passed March 17, 1949, was discussed following a letter read by Mayor Ufford from Glenn Norton centering on building code violations. A building under construction is not following the ordinance's requirments. After more discussion it was moved by Bruce Cole and seconded by Lynn Schoonover to revok Ordinance #8 as of tonight's meeting. Motion carried, una.

Immediately Davy Jones moved to up-date the content of Ordinance #8 within 90 days. Motion was seconded by Bruce Cole and carried, una.

Council appointed Mrs. John Ramsey to the library board.

A letter from the Telephone Co. asking approval on city easement form and a signature was discussed. Council agreed to sign the letter with conditions.

The city received a complaint through the Board of Health concerning the water loading station south of town. Dale Fox will talk to the Co-op about the matter.

Dale Fox, maintinance man for the city, reported on the inadequacy of the city's water supply. Council agreed to hold a special meeting to discuss the city's water supply system.

The county commission has given the city premission to put reduce speed signs at the north and south edges of the city. The city needs to purchase the two signs now.

Ted Watchous entered the meeting at 10:05 p.m.

Council agreed with Nadine Cordts's suggession that the city needs a permanent plan for snow removal from the city streets. Possibly lining up the farmers? No action was taken.

Suggestion was made to limit salesmen's time who appear at council meetings in the future.

Bruce Cole reported the Housing Authority is continueing to meet with appraisers, architects and waiting on some paper work.

The city is interested in Cable TV.

A copy of the zoning ordinance will go to the board of appeals.

There is a need to get some bids for street repairs.

Council ask the newspapers to print a reminder of the build ing permits required.

The dog problem was discussed. The city now has an agreement with the Helping Hand Humane Society in Topeka.

On motion of Lynn Schoonover the meeting adjourned at 11:00 p.m. to a special meeting May 22 at 7:30 p.m. to discuss the city's water supply system.

Water Supply Engineering Report of February, 1978

General

The City Council of Overbrook, Kansas on August 23, 1978, authorized Kramer Engineering and Surveying, P.A. to proceed with improvements to the City's water supply.

The purpose of this Addendum is to present the final plan for water supply improvements and new estimates of cost based on the proposed improvements.

Proposed Improvements

The following improvements have been authorized to be made to the Overbrook water supply:

- 1. Water Wells. Two (2) new water wells are to be constructed. Each well is expected to have a capacity of 35 g.p.m. and be approximately 420 feet deep.
- 2. <u>Chlorinator Building</u>. A concrete block building, with piping, meters, valves, manual well pump controls and chlorinators, is to be constructed, west of the existing well house no. 2.
- 3. <u>Piping</u>. New piping is to be installed in well house no. 2. Connecting pipelines between the existing wells, the new wells and chlorinator building and existing supply line to the City, is to be installed.

Preliminary layouts of wells, chlorinator building and pipelines are shown on attached layout sheets.

Estimate Of Cost

The cost of the improvements, as authorized by the City, are shown in the following estimate. The various costs and prices are estimated and approximate, though determined as accurately as the scope of this study would permit.

Tom Miller had contracted the Mayor to resign as a patrolman for the city.

In an elfort to societable city's unccreasing demand for water, 10ver brook's city resuncil allowed wight. voted anatimiòusly to drill a new well and to contact the Osage County Rural Water District No. 5 to express an interest in obtaining water sonce the pipeline is completed.

Council members decided to make an application to the state Board of Water Resources to dig two wells with the provision that one would be dug "as soon as possible" and the second to be installed within five years if needed.

Although no definite site was approved Monday night, tentative plans indicate the well will be located about one half mile north of the city's third well, which is 41/2 miles east of Overbrook near the old Enterprise School.

According to a recently-completed survey of the Overbrook water system by the city engineer, Jack Kramer, Topeka, the two new wells could be added to the present system without constructing a new chlorinator to treat the water.

In the survey Kramer called for at least one new well to increase the water pumping capacity to 160 gallons per minute, plus a new treatment plant, pumping station and necessary pipelines. The cost for such construction would be about \$185,000, with the well alone costing about \$15,000.

The increase in pumping rate will

be needed. Bramer said Tormest the antioipated 186, 190 gallons of water used daily by 1,100 expected residents of Overbrook in the year 2000. The city's three wells presently pump an average 73,000 gallons per day to 793 assidents. residents.

If the city continued to use its presently existing three wells, the third of which was built in 1969, Kramer estimated that the demand for water should not exceed the supply until 1983, assuming the pumps would be operating about 20 hours daily.

Dale Fox, who maintains the wells for the city, told the council that the pumps are already operating 24 hours a day to keep up with demand. Kramer had estimated that 24 hour pump operation would not be needed until 1990.

It was pointed out by council members that a 1972 study by Kramer recommended that two wells be dug then to meet the city's expanding population.

We've been lax in not being on top of this thing," Mayor Calvin Ufford

Council members expressed hope that their action would help the situation within the next year but by making the second motion they hoped the water problem could be alleviated for the next 20 years.

By hooking up with the Osage County rural water line or even with the Douglas County Rural Water

District No Stime the council noted that the new water source water would serve as a "lookeap" to the wells, eventually could become the city's primary water supply. However, such a legiculal be more costly to the city than drilling the wells. Ultaca told the council. The water probably would be sold to the city in a set number of gallons per month, he said, and the city would be liable to pay for the amount whether it used all of it or not. .

For example, Kramer suggested in his study that, if Overbrook bought water from the Douglas County district, the yearly cost could be \$28,500 per year assuming the district charged Overbrook \$1.30 per 1,000 gallons. Kramer's study based the figure on a 72 cent-cost to produce the water at Lawrence, which in turn sold it to the Douglas County district for \$1 per 1.000 gallons.

That \$28,500 cost, Kramer noted, was nearly half of the city's expenses.

Payment for the well's construction cost could be covered by either revenue bonds or general obligation bonds or a combination of both. By law, revenue bonds may be issued by the council without an election, but general obligation bonds must meet with voter approval.
