Re: Norma's Tavern

Dear Mayor Coffman:

I have examined the March 26, 1976, report of City Marshal R. Brown and the Kansas statutes relating to cereal malt beverage licensing, a copy of which is enclosed.

While I cannot by any means guarantee the District Court would confirm the governing body's revocation of this tavern owner's license, I think the officer, together with the Osage County Sheriff's deputies, has gathered evidence upon which the governing body is obligated to act.

The governing body has three options:

- (1) It may proceed to have a hearing to determine whether the license should be revoked or suspended.
- (2) It can ask me, as City Attorney, to file a civil action in District Court to enjoin the tavern operator from selling cereal malt beverages; or
- (3) It can request the officer file a complaint in City Court charging the tavern owner with misdemeanors.

Frankly, I would suggest the governing body hold a hearing to determine whether the owner's license should be revoked or suspended. Although, pursuant to K.S.A. 41-2708, the governing body would have to give the licensee five days' notice of hearing, and then conduct a hearing at which the licensee would have the right to attend and offer evidence in her defense, still this procedure forces the licensee to take the action necessary to get the matter into District Court, by appeal from the governing body's decision, in contrast with the injunction or criminal proceedings, which the City must institute. In addition, should the governing body decide, at the hearing, to revoke or suspend the license, that action remains in effect pending the licensee's appeal to District Court.

I believe you have a copy of the officer's report. From it, I conclude the licensee may well have violated K.S.A. 41-2708(b)(e)(g) and (h), as follows:

(1) 41-2708(b) because, "the provisions of the act" include the 41-2704 prohibitions against the sale of cereal malt beverages between twelve midnight and six o'clock a.m., and the operating of a private room in the tavern. I am not confident you could prove they were selling cereal malt beverages between midnight and six a.m., but I am pretty confident you could prove they were operating a private room in the tavern, in violation of the statute.

(2) 41-2708(e) because there might have been a sale of beer to minors Kimberly Gowers and Mario Barbosa. However, without these two as witnesses, we probably could not make this stick, on appeal.

(3) 41-2708(g) because there was obviously gambling going on.

(4) 41-2708(h) because it appeared drinks were being mixed. This also would be difficult to prove, unless the officers smelled or tasted what was in the glasses, but the mere possession of alcoholic liquor in a tavern is a violation of 41-2704.

In short, I think the governing body should, within the next few days, determine whether or not it wishes to proceed further with this and, if so, in which of the three types of actions. Should the governing body accept my recommendation of holding a hearing to determine whether or not the license should be revoked or suspended, the date picked for the hearing should be far enough ahead to give me opportunity to prepare and deliver notice of the hearing to the licensee well in advance of five days prior to the hearing.

The regular meeting of the Overbrook City Council was held on April 14, 1976, at 7:30 p.m. Councilmen Cuncan, Hummel, and Ufford were present. Dale Fox, Bov Brown, and Earl Warren were also in attendance. Mayor Coffman presided.

The minutes of the March 10, 1976, regular council meeting were read and approved with no additions or corrections.

Dale Fox informed the council that Environment Laboratories in Topeka will perform services needed to comply with State Health Department requirements for testing sewage. The services provided include on site collection and reporting for a quarterly charge of \$47.30. A motion was made by Duncan to have Dale make necessary arrangements for engaging services of the laboratory. The motion was seconded by Hummel and passed.

Ufford moved to pay the bills. Duncan seconded the motion and it passed.

Minutes of 4-14-76 Meeting Cont'

The council discussed the dog situation and decided to crack down on owners of dogs who do not observe the leash law. It was also agreed to have Mayor Coffman and Dale Fox put an article in the paper to notify residents of the council's intentions.

Duncan moved to grant Bob Brown an increase in pay of \$35 per month. Ufford seconded the motion and it passed.

Duncan reported it would be necessary for the city to transfer some money into the swimming pool account to get the pool operations started. Ufford moved to place \$500.00 of revenue sharing funds in the swimming pool account. The motion was seconded by Hummel and passed.

Specifications for solid waste disposal were read by Ufford and it was decided to publicize that the council will accept bids from trash haulers for opening on May 12, 1976.

The council discussed alleged acts of Norma Mitchell which are considered to be violations of her right to hold a cereal malt beverage license. Mayor Coffman indicated he would check what could be done to correct the problem.

Regular Meeting of Overbrook City Council--May 12, 1976

The regular meeting of the Overbrook City Council was held on May 12, 1976, at 6:30 p.m. Councilmen Duncan, Hummel, Stout, and Ufford were present. Dale Fox, Bob Brown, Jim Hayes, and Lester DonCarlos were also in attendance. Mayor Coffman presided.

The minutes of the April 14, 1976, regular council meeting were read and approved with no additions or corrections.

It was moved by Stout and seconded by Hummel that Lorraine Duncan be appointed to fill the position on the Library Board vacated by Mrs. George Maichel. The motion carried.

Representatives from the Continental Telephone Company advised the council that a ~~an ordinance~~ <sup>license</sup> is no longer required in order for their company to operate in a city, and stated that the regular rate would have to be charged for the City's fire phone service. Mr. Thompson from the company's office in Osage City indicated he would furnish the council with a copy of an ordinance used by other cities for its consideration which would provide for a gross receipts tax. He also agreed to check on the cost of installing an automatic control for the City's water wells and assured the council that the company would repair damages from recent trenching of alleys by the company in the city.

Bids for trash hauling were opened. A bid of \$3.00 was received from Simpson's Sanitation service for monthly pick-up of trash for each city resident. A bid of \$1.90 was received from Greens' Sanitation Service for the trash pick-up. The council decided to postpone making a decision toward awarding a contract until the next regular meeting. *A list of businesses was made, and each bidder was asked to quote a price for hauling trash of each business*

Stout moved to pay the bills. Hummel seconded the motion and it passed.

Stout moved to transfer \$10,000 of funds in a checking account at the First National Bank to a Certificate of Deposit for five months. Duncan seconded the motion and it passed unanimously.

The hearing scheduled for nine o'clock concerning the cereal malt beverage license of Norma Mitchell was convened upon the arrival of Steve Jones. Those present for the hearing included Ed Mitchell, Norma Mitchell, Charles and Tony Fawl, and Jim Gardner, Osage County Sheriff's Deputy. Bob Brown described the allegations on behalf of the city toward misuse of the license issued to Norma Mitchell or violations of state law governing an establishment licensed to sell cereal malt beverages. Everyone interested in doing so was given an opportunity to ask questions or otherwise express themselves in regard to the matter. The council convened in a closed session and when it returned Ufford moved to suspend the license issued to Norma Mitchell for a period of 60 days commencing the first of June. The motion was seconded by Hummel and passed unanimously.

The planned use report for revenue sharing funds to be received during the period of July 1, 1976, to December 31, 1976, was approved for publishing.

Hummel moved to pay for the cost of repairing damage to Bob Brown's car that occurred through apparent vandalism while he was on duty. Ufford seconded the motion and it passed.

Duncan moved to adjourn. Ufford seconded the motion and it passed.

Regular Meeting of Overbrook City Council--July 14, 1976

The regular meeting of the Overbrook City Council was held on July 14, 1976, at 7:30 p.m. Councilmen Duncan, Stout, and Ufford were present. Dale Fox, Bob Brown, Jim Hayes, and Mr. and Mrs. Kenneth Green were also in attendance. Mayor Coffman presided.

A motion was made by Stout to approve Mayor Coffman's endorsement of Davi Jones to fill the unexpired term on the council of Jean Ingersoll who resigned her position on the council. The vote on the motion was unanimous in favor of the appointment, and Mrs. Jones accepted the oath of office.

Mayor Coffman announced that the case involving Norma Mitchell's beer license had been brought before district court earlier in the day of the council meeting. He stated the judge upheld the City's 60 day suspension, and as a result Norma's license will be suspended a total of 60 days including the time during which the suspension was in effect prior to the court date.

Ufford stated he had spoke with City Clerk, Leonard Atchison regarding his interest in resigning. Ufford informed the council that Atchison confirmed his desire to resign provided a suitable replacement could be found. Ufford informed the council that Barb Williams is interested in the job, and he would be in favor of installing her as city clerk as soon as she can be worked into the position. The other council members agreed with Ufford's proposal, and Barb will be asked to attend the next meeting to gain familiarity with the job.

Jim Jungman informed the council of his thoughts concerning the proposed drilling of a new City well. The discussion mostly centered upon the most suitable location for drilling the well, and Jungman advised it would not be wise to go west of the existing wells. If it is necessary to cross the road to the west he recommended it would be best to stay as close to the road as possible. Mayor Coffman and Bob Duncan plan to contact Bill Baldwin and Leona Wright about obtaining rights to drill on their property.

Kenneth Green asked the council if it had received any complaints toward his trash hauling service. A couple of minor complaints were discussed, and it was not necessary to have Green do anything about the complaints at the present time. Green then mentioned that two businesses, Strawberry Patch and Brookside Manor, had more trash than he expected, and he wanted to know what would be the proper steps to take in increasing his charge to the two businesses. The council suggested that he talk to Duane Wilson and Cliff Fischer regarding the problem with their respective businesses. Green indicated he did not feel he could reach an agreement with Fischer, so the council decided to invite Fischer to the next council meeting in hope of deciding upon an agreeable rate.

A proposed ordinance for enacting a telephone franchise agreement was presented by the Mayor. The council reviewed the proposed ordinance and decided to return it to the telephone company with a request for a 3% gross receipts tax and the addition of a section providing for fire department phone service at a constant rate during the period of the franchise agreement.

Duncan moved to pay the bills. Jones seconded the motion and it passed.

Discussion of the street repair followed. Blacktop bid was \$300 a street, \$75 an intersection with no patching. \$25 a ton for patching. Approx. total \$11,300. Hamm's bid was \$14,975. Bid includes patching and they had an itemized list as to how much per street to be repaired. Hummel moved to give contract to Blacktop if the material met the same specifications as Hamm and the city could pay for half when the job is completed and the balance at the end of the year. Ufford seconded the motion. The vote ended in a tie, Jones and Duncan against and Ufford and Hummel for.
