


### What is PS-MAPP?

### Partnering for Safety and Permanence-Model Approach to Partnerships in Parenting

- A comprehensive preparation and selection program for resource families\* designed by the Child Welfare Institute, Duluth, Georgia.
- Focuses on safety, well being and permanence for children in foster care.
- Helps resource parents develop skills for parenting children in foster care.
- Provides a process for prospective resource parents to make an informed decision about their ability, willingness and readiness to become resource families.

### **PS-MAPP** is:

- Required by the state of Kansas for anyone wanting to become a licensed resource family.
- A series of ten sessions that meet once a week for 3 hours, for a total of 30 hours of training.
- Led by a certified team of professional staff and experienced resource parents.
- For everyone living in your home, 18 years of age and older, who will be sharing parenting responsibilities.
- Available at no cost to the participants.
- Open for registration in your area by calling 1-888-655-5500.



What
happens after
PS-MAPP
training
is completed?



- Each person, who completes all ten sessions of the training, the Family Profile, home consultations, and strengths/needs assignments will receive a certificate.
- Families who want to adopt can pursue an adoptive home study.
- Families who want to be a resource family will be licensed through the Kansas Department of Health and Environment.
- Additional training is available after PS-MAPP to help with parenting issues and to assist resource parents with annual continuing education requirements. Monthly support groups for resource parents are also available.

<sup>\*</sup>A resource family (another term for foster family) is a family willing to provide short term care or serve as the adoptive or legal guardian for a child in foster care.
